**Final Project Summary:** The purpose of this project was to increase shoreline based fishing opportunities for anglers who do not own boats, anglers with limited mobility and to improve access to Chowan River and Albemarle Sound for anglers with boats. The construction phase of this project was implemented and completed by RPC Contracting, Inc. The construction consisted of renovating a 600 foot long fishing pier into a managed, universally/ADA accessible, safe, and functional fishing pier. Construction included the incorporation of elements such as restrooms, overhead lighting, and benches as well as safety features such as handrails.

The bridge deck level was modified to create a suitable fishing deck and handrails were installed to provide ADA accessibility. The pier includes public restrooms and a concession area.

Existing launch ramps were renovated to include two 15 foot wide concrete launch ramps, one floating and two fixed courtesy docks, new bulkhead structure, the canal was dredged and trees were removed to allow deeper water depth and navigation accessibility. Construction also included overhead lighting; paved access roads, parking areas and stormwater run off treatment devices to minimize adverse impacts to water quality.

Project completed and open to the public. Ribbon cutting ceremony held June 18 2010.
