

## Commercial License and Permit Application Instructions and Forms

This site can be used to download application instructions and application forms for NC Division of Marine Fisheries Commercial licenses and permits.

### General Instructions

Please read the following before downloading any applications or forms:

1. Although application forms are available for downloading, you may find it easier to stop in any DMF license office to apply for a license or permit. Our offices have photocopiers and notary publics that can make the process easier. Our offices also have well trained staff that can also assist you in obtaining the proper permits for specific fisheries and answer any questions you may have.
2. If you chose to download an application, please take care to read the specific instructions for each application. Requirements may differ between the various licenses and permits.
3. **If you do not currently hold a DMF license or permit** or have not applied to the License Eligibility Board for a standard commercial fishing license then you must complete the [Application for Participation](#).
4. A **Certification Statement Form must accompany all applications**. A notarized signature is required for all new licenses and permits. Be sure to use the proper certification form as they differ for new licenses and renewals.
5. We now have renewal applications for **Standard Commercial Fishing Licenses (SCFL)** and **Retired Standard Commercial Fishing Licenses** available for downloading. Applicants for new SCFL's must complete the [Application for Eligibility Board](#).
6. We do not have **Assignment forms** available for downloading. These are currently three-part carbon forms available from any license office.
7. Some license applications have a survey at the end. Please complete all surveys to the best of your ability.
8. Mail completed applications to the address shown at the bottom of each application.

- [Coastal Recreational Fishing License Exemption Permit](#) - *individuals or organizations can apply for an exemption from recreational fishing license requirements to conduct organized activities benefiting individuals with physical or mental limitations, military appreciation, educational events or disadvantaged youths.*
